

PRIVACY POLICY

General

EPPIC ASIA Co., LTD., (Hereinafter referred to as “EPPIC”) handles a variety of information: including our own information and information entrusted to us by you. This Privacy Policy describes how EPPIC collects and uses personal information where EPPIC is the data controller or where EPPIC refers to the applicability of this Policy to cope with the Thailand Personal Data Protection Act 2019 (PDPA). Our employees received training to comply with data protection law and safeguard your privacy. This document explains how your data is used and what your rights are.

Information Collection

EPPIC requests information from you to process your purchase orders or to place purchase orders to you and other channels that may be used to personally identify you (“Personal Information”) including but not limited to:

- General data such as your name, gender, and nationality.
- Contact data information such as your telephone numbers, mailing addresses and email addresses.
- Financial information such as billing information including billing address and tax ID.
- Business information such as company name, business address and associated contact information.
- Product data such as information about quotes and product information.
- Technical information such as IP address.

Use of Information Collected

- To process EPPIC business transactions.
- To process your job application.
- To improve our EPPIC website and services.
- To comply with any legal or regulatory requirement.
- For financial purposes such as accounting, billing, and audits.
- For management and administrative purposes.
- For all other purposes ancillary to any of the purposes stated above.

Disclosure of Personal Information

EPPIC may processes and discloses your Personal Information with third parties appointed or authorized by EPPIC, who may be located within or outside the Kingdom of Thailand for the fulfilment of the Purpose:

- Business partners and alliances.
- Government or non-government authorities and regulators.
- Insurers.



Protection of Personal information

EPPIC stores all business data collected securely at a server outside of the Kingdom of Thailand. All computers are secured by passwords.

Data Controller

Any personal data provided or gathered is controlled primarily by EPPIC and personnel trained to comply with the PDPA.

Retention of Data

EPPIC will keep your information for as long as EPPIC needs it for the purpose it is being processed for. Where your information is no longer required, EPPIC will ensure it is securely disposed. In some circumstances EPPIC may need to store your personal information for longer periods of time, for instance where EPPIC is required to do so in accordance with legal regulatory requirements. EPPIC will remove or anonymize your information after 7 years.
